Summary/Background: The County Engineer was authorized to acquire Right of Way and approved by this Board by Resolution 21-960. Although negotiations are ongoing and settlement may be reached, the County Engineer advises that it is necessary to appropriate a certain parcel of land for additional right of way on the Brint Road & Centennial Road Roundabout Project, PID 110345 from the following:

Section 2. This Board hereby directs and authorizes the Clerk of the Board, through the Lucas County Engineer to request the Lucas County Prosecuting Attorney to file a petition for appropriation and to institute appropriation proceedings in accordance with Section 163.04 of the Ohio Revised Code to allow the said roadway improvement project to proceed.

Section 3. This Board approves and requests the Lucas County Auditor to issue a check in the amount listed above in the name of "Lucas County Clerk of Courts" from License Plate Fees and Gas Taxes ~ 2041.210004.57.610018.ET057.00000 for delivery to the Lucas County Engineer.
